Physical Eligibility Requirement Dropped

NCCCO is removing the eligibility requirement for candidates to attest to having had a physical examination. The change is effective January 1, 2020 and applies to all NCCCO operator certifications. The physical demands placed on a certified crane operator are known only to the employer rather than the certification body, said NCCCO CEO, Thom Sickelsteel. [Read More](#)

OSHA has issued a [Memorandum](#) to all its Regional Administrators and State Plan Designees that underlines the need for certification bodies offering certification for crane operators to be accredited by a nationally recognized accrediting body such as NCCA or ANSI. Effective January 1, 2020, NCCCO will implement a streamlined fee structure for many of its candidate certification and recertification exams, including most paper/pencil tests, computer-based tests, and practical exams. The new fee structure features a single fee for each exam, regardless of which certifications candidates currently hold. The new fees include a new NCCCO certification card issued to certificants each time they add another certification, eliminating the time and expense of ordering updated cards and ensuring that cards show all certifications currently held. Commissioner Spotlight: Troy Krumm

Back in 1979, Troy Krumm was hired by Link-Belt Cranes and, apart from a brief stint with a Link-Belt distributor, has been employed by the company ever since. His crane roots go further back even than that, however; his father was the service manager at a Link-Belt distributor in Cedar Rapids, Iowa, and Troy cut his crane teeth doing odd jobs around the shop, helping the mechanics. "I kind of grew up in the industry," Krumm says. Eventually he found himself going out on field service calls. "That's how I learned how to operate and run a crane," he recalls. Throughout the years Krumm has held a variety of positions and in a variety of locations around the country. Did You Know?

As of January 1, 2020, candidates who add certifications to their existing certifications will no longer have to request, or pay for, an updated card. Under the old fee structure, NCCCO charged candidates who added a certification to their current card a fee if they wanted to update their card. NCCCO will no longer charge this fee and will automatically send out an updated certification card every time a certificant adds a certification!

Cal-OSHA publishes its landmark six-year study revealing an 80% drop in crane-related fatalities following California's requirement for crane operators to be certified. This conclusive evidence demonstrating the effect of accredited certification in saving lives and reducing the incidence of injuries and accidents helps push the ailing federal rule closer to publication.
